

COLLEGE OF BUSINESS ADMINISTRATION CORE REQUIREMENTS:

To be able to take the CBA core courses, you must have:

1. 54 credits earned or in progress
2. Completed (or in progress) with a minimum grade of “C” in the following courses:
  - a. ECO 110
  - b. ECO 120
  - c. ACC 221
  - d. ACC 222
  - e. BLAW 205
  - f. MTH 160 or 175 or 207
  - g. ENG 110 or 112
  - h. STAT 145 or 245
3. In addition to completing the above courses before taking the CBA core courses, all CBA students must eventually pass the following courses:
  - a. ECO 230
  - b. IS 220
  - c. MGT/MKT 301

CBA CORE COURSES:

1. FIN 355
2. MGT 308
3. MGT 393
4. MKT 309
5. MGT 449 (in last semester, after completing the previous four)

GRADUATION REQUIREMENTS:

- 120 total credits
- 2.00 resident cumulative GPA
- 40 credits at 300/400 level
- 30 units in-residence at UWL
- Maximum of 21 Pass/Fail credits
- Maximum of 15 internship credits

RISK, INSURANCE, AND FINANCIAL PLANNING MAJOR REQUIREMENTS:

Must take the following five courses:

1. FIN 360: Principles of Insurance and Risk Management
  - a. Or: FIN 363: Insurance Planning (prerequisite: FIN355)
2. FIN 370: Corporation Finance (prerequisite: FIN 355)
3. FIN 380: Principles of Investment (prerequisite: FIN 355)
4. FIN 390: Money & Capital Markets (prerequisite: FIN 355)

5. FIN 485: Problems & Cases in Finance (prerequisite: FIN 370)
  - a. Or: FIN 475: Investment Analysis & Portfolio Management (prerequisite: FIN 380)
  - b. Or: FIN 460: Case Studies in Financial Planning (prerequisite: FIN 363, FIN 380; FIN 408; senior standing)

As electives, must take one of the following Group 1 courses:

- FIN 361: Life Insurance (prerequisite: FIN 355)
- FIN 407: Advanced Financial Planning (prerequisite: FIN 355; senior standing)
- FIN 408: Retirement Planning (prerequisite: FIN 355)
- FIN 409: Estate Planning (prerequisite: FIN 355)

As electives, must take one of the following Group 2 courses (or an additional Group 1 or capstone course):

- ACC 303 (prerequisite: FIN 355)
- ACC 311 (prerequisite: ACC 221)
- ACC 330 (prerequisite: ACC 311)
- ECO 301 (prerequisite: ECO 110, ECO 120)
- ECO 307 (prerequisite: STAT 145 or STAT 245; ENG 110 or ENG 112)
- FIN 400 (prerequisite: junior standing)
- FIN 410 (prerequisite: FIN 390 or ECO 301)
- FIN 437 (prerequisite: FIN 355)
- FIN 440 (prerequisite: FIN 355)
- FIN 450 (prerequisite: FIN 355)
- FIN 456 (prerequisite: FIN 355)
- FIN 499 (prerequisite: instructor consent)
- MKT 362 (prerequisite: MKT 309)
- MKT 370 (prerequisite: MKT 309)

IMPORTANT NOTES:

Doing the required gen-ed, CBA courses, and FIN courses (and nothing else) would put you at **97 credits**. That means you need **23 more to get to the 120 required to graduate**. These could be courses that apply towards a minor or double-major. Any time you can't fill out a full schedule with the required courses, remember that you eventually need 120 to graduate. Due to the high demand for CBA courses, you may want to consider programs outside the CBA.

**Also, these requirements are specific to the current University Catalog.** Be sure to check your WINGS advisement report to be sure your requirements are not different.
